RUN FOR LIFE - NON-COMPETITIVE RACES

10km – 5km

MARCH 9, 2025 - MONZA PARK

SOCIALTIME, in collaboration with I Gamber de Cuncuress and the Silvia Tremolada Aps Association, is organizing the tenth edition of RUN FOR LIFE. The event, organized to coincide with Women's Day, aims to promote respect as a necessary condition for civil coexistence between men and women. The initiative is for charity. The proceeds, in addition to the organized costs, will be invested in planting an area of the Monza Park.

The non-competing 10km and 5km races will take place on Sunday 9 March 2025 with the 10km and 5km starting at 9.15am.

ELIGIBLE FOR PARTICIPATION:

The following are eligible to participate in the 10km and 5km:

- everyone without age distinctions.

At the time of registration, those who wish to participate at RUN FOR LIFE 2025 will have to sign the declaration of responsibility, as per the text below:

STATEMENT OF RESPONSIBILITY: "I hereby declare, aware of the criminal sanctions provided for in the event of untrue declarations and false statements in the documents (art. 26 l. 15/68 and art. 489 cp): to have read and consequently know, accept and respect the rules of "RUN FOR LIFE 2025"; to be aware that participation in sporting events is potentially a risky activity if one is not adequately prepared and in suitable physical condition; to register voluntarily and to assume all risks arising from my participation in the event: falls, collisions with vehicles, with other participants, spectators or others, weather conditions, including scorching heat, extreme cold and/or humidity, traffic and road conditions, any type of risk well known and assessed by me. Being aware of the above, considering the acceptance of my registration, I, on my behalf and in the interest of no one else, release the Organizing Committee of the RUN FOR LIFE NC, SOCIALTIME ODV, GAMBER DE CUNCURESS, FIDAL, the Municipality of Monza, the Villa Reale Consortium, the Lombardy Region, the promoters, all sponsors and organizing partners of the event, their respective representatives, successors, officials, directors, members, agents, collaborators and employees of the companies mentioned above, of all present and future claims or responsibilities of any kind, known or unknown, arising from my participation in the event.

Once the registration for RUN FOR LIFE 2025 has been accepted, the participation fee is not refundable, even in the event of cancellation and in the event that the race is cancelled and/or postponed to another date or not carried out due to force majeure and/or reasons not attributable and/or not attributable to the will of the Committee Organizer, including the revocation of the authorization to carry out the event by the competent public bodies.



By registering for the event, I expressly authorize the Organizing Company, together with the legal entities with which it has professional and commercial relationships, to take images of the event, to acquire free of charge the right to use the still or moving images in which I may appear, taken on the occasion of my participation in the competition on all visual media as well as on promotional and/or advertising materials produced and distributed throughout the world and for the maximum time foreseen by the laws, regulations, treaties in force, including any extension that may be made to the foreseen period. I also declare that I have read the ao

The data will be processed in compliance with the provisions of EU Regulation no. 2016/679 ("GDPR") and used exclusively for the purposes set out in the information published on the website www.runforlifeitaly.it."

REGISTRATIONS AND PAYMENTS:

Registrations are open and you can register via the link published on the website www.runforlifeitaly.it

10km:

- €13 until 31 December 2024
- €15 from 01 January to 31 January 2025
- €17 from 01 February to 05 March 2025 (for online registrations)

5km:

- €9 until December 31, 2025
- €10 from 1 January 2025 to 31 January 2025
- €12 from 01 February 2025 to 05 March 2025 (for online registrations)

NB The race will not be supervised by the FIDAL GGG.

The registration fee for RUN FOR LIFE 2025 includes: BIB, rental of time recording chip (only for the 10km), race pack with official technical t-shirt and sponsor product, refreshments and sponging along the route, final refreshment, services, insurance, finisher medal, finisher diploma downloadable from the website, technical and medical assistance.

Registrations without the athlete's complete personal data will not be accepted.

Registration for the RUN FOR LIFE Non Competitive Races can also be done in the following ways:

From January 8, 2025 until March 5, 2025 at the following physical registration points:

On the race course (subject to bib availability):

RACE PROGRAM:

BIB Collection:

Saturday 08 March 2025 from 10.00 to 18.30 Sunday 09 March 2025, from 7.00 to 8.45

at the organizing secretariat located at the Monza National Racetrack

At the same time as the delivery of the certificate, the race pack will also be delivered. The BIB and the race pack may also be collected by third parties, with written authorization and a photocopy of a valid identification document.

The BIB is strictly personal, cannot be tampered with and is not transferable to anyone.

Anyone found on the race track with a BIB assigned to another athlete or without a regular number or a counterfeit number will be held responsible for damage to property and persons, including himself, in addition to incurring the sanctions imposed by the federal bodies and the sanctions provided for by current legislation.

TIMING

The timing and rankings will be using a chip system time track only for the 10km.

SUPPLIES

As per WA/FIDAL regulations. A final refreshment point is planned in the arrival area.

BAGS DEPOSIT

Together with the bib, you will be given an adhesive tag with your race number which must be applied to the bag/sack of the athlete who will complete the last leg and which must contain only the personal clothing of the participants (to be used for the post-race change).

The bag, duly numbered, will be collected, stored and returned at the end of the race, to the designated "BAG DEPOSIT" area, duly marked. It is recommended not to leave personal effects (cell phone, wallet, etc.) inside the bags. The organization will not be responsible for any theft.

ATTENTION: ONLY BAGS DELIVERED WILL BE ACCEPTED AT THE BAG STORAGE FROM ORGANIZATION TO RACE PACK COLLECTION



TIME LIMIT

The time limit for the 5km and 10km is 100'; beyond this time the organizing committee will no longer be able to guarantee the complete closure of the race course.

RESULTS

For the 10 km they will be available on the event website.

GENERAL INFORMATION:

Health service

The organizing committee will provide an adequate medical assistance service along the route and at the starting and finishing points.

Transfer of registration

Athletes who are already registered but unable to participate in the race have the possibility of transferring their registration to another athlete who meets the participation requirements set out in this regulation.

It is also possible to change the race by transferring the registration already made to a different distance. In this case, any increase in the registration fee must be paid at the end of the course. Differences in the registration fees will not be refunded.

The change of name and/or race must be reported to the secretariat by March 5, 2025 at the info@runforlifeitaly.it mailbox which will send the link through which it is possible to make the substitution.

Privacy and Image Rights

Pursuant to Legislative Decree no. 196 of 06/30/2003 ("Consolidated Law on Privacy"), we inform you that the personal data collected will be used only to prepare the list of participants and the historical archive, to provide the event services, to send information or advertising material of the "RUN FOR LIFE 2025 NON COMPETITIVE" or its partners.

By registering for one of the events of the "RUN FOR LIFE NC" event, the athlete expressly authorizes the organizers, together with the media partners, to use still or moving images in which he/she may have been filmed during his/her participation in the race on all media, including promotional and/or advertising materials, throughout the world and for the maximum period of time provided for by the laws, regulations and treaties in force, including any extension that may be made to the foreseen period.



Failure to perform

In the event that the race is cancelled and/or postponed to another date, or in any case, not carried out due to force majeure and/or reasons not attributable and/or not attributable to the will of the Organization, including the revocation of the authorization to carry out the race by the competent public bodies, the registered participant will have no right to claim anything from the Organizing Committee and/or from SOCIALTIME and I GAMBER DE CUNCURESS, neither for the refund of the registration fee, nor for the reimbursement of any expense incurred or to be incurred.

The submission of the application for registration constitutes acceptance of this clause and express waiver of any claim resulting from the cancellation and/or postponement of the competition.

Warning: the organizing committee reserves the right to modify these regulations at any time for reasons it deems appropriate for the purpose of better organizing the race, subject to authorization by Fidal. The event will take place in all weather conditions.
